

# FY22/23 OPERATING SUPPORT GRANT

## Extension for Current Operating Support Grantees



Due to the impact of COVID-19 on Nevada's arts organizations, the Nevada Arts Council will allow current FY20/21 Operating Support Grantees to extend their grant for two more years (FY22-FY23: July 1, 2021 – June 30, 2023) without going through the full application and review process. This extension will allow grantee organizations to save time and resources so they may focus on delivering their mission, pursuing other funding opportunities, and creating programming to serve Nevadans safely and sustainably.

To be eligible for the extension, current Operating Support Grantees must be in good standing with the Nevada Arts Council and must have submitted all required reports and documentation for their FY20/21 Operating Support Grant.

### EXTENSION APPLICATION

**DEADLINE:** July 30, 2021

**ELIGIBILITY:** Current Operating Support Grantees only

### GRANT AMOUNT

Equal to FY20/21 OSG award

### PERIOD OF SUPPORT

FY22/23: July 1, 2021 – June 30, 2023 (2-year extension)

**GRANT AMOUNT:** The FY22/23 grant award for each organization will be equal to their FY20/21 award amount. The 1:1 cash match each year is still required.

This grant will be administered in two payments during the two-year grant cycle:

1. Grantees will receive 100% of the 1<sup>st</sup> year of funds immediately upon receipt of the signed grant paperwork
2. Grantees must complete the Interim Report online by June 30, 2022
3. Upon approval of the Interim Report, grantees will receive their full 2<sup>nd</sup> year of funding
4. Grantees must complete the Final Report online by June 30, 2023 to remain in compliance and eligible for future NAC grants

**NEW: Documentation of the use of grant funds for each year must be provided in the Interim and Final Reports and must match the proposed expenses. Acceptable documentation includes receipts, payroll records, financial statements, or other official proof of payment**

**FUNDING RESTRICTIONS:** Funds must support general operating expenses including, but not limited to, administrative salaries and benefits, payroll expenses, insurance, facility space rental, utilities, and contracted and professional services. Grantees must also review the General Funding Restrictions in the [FY22 GRANT POLICIES](#).

**HOW TO APPLY FOR EXTENSION:** All current Operating Support Grantees will receive a private link via email. This link will take them to the FY22/23 Operating Support Grant Extension application in Submittable. Grantees will fill out a short application confirming their contact information, eligibility, and outlining the proposed use of grant funds for the next fiscal year. The extension application must be completed and submitted no later than July 30, 2021. Upon approval of the extension application, grantees will receive a new award packet with all details for the FY22/23 grant.

All eligible Nevada arts non-profit organizations, including Operating Support Grantees, will have the opportunity to apply for additional FY22 funding through the Nevada Arts Council's American Rescue Plan Grant (to be announced).
